# Section 4 - First Aid Measures

## Section 6 - Accidental Release Measures

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or watercourses. # Section 7 - Handling and Storage

Exposure limits have not been set for any ingredient in product. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. ingredients in this product. There is a blanket limit of 10mg/mP<sup>3P</sup> for dusts or mists when limits have not otherwise been established. The nature of this product makes it unlikely that this level will be approached in normal use.
