Section 6 - Accidental Release Measures

Accidental release: For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. Section 7 - Handling and Storage

Store away from farm chemicals e.g. insecticides, fungicides and herbicides.

Exposure limits have not been set by SWA for other ingredients in product.
